Cantrell was elected an artist member of the Silvermine Guild of Artists in 1998, when she retired from work as a typesetter in NYC. She has been painting and making prints full time for the past 27 years, most recently large-scale woodcuts and landscape paintings in an expressionist gestural style. An indelible early inspiration was Richard Diebenkorn and the Bay Area expressionist realist painters.
